

2024 Club Budget Period 1 January 2024 to 31 December 2024

The Responsible Entity determines the Annual Club Budget, which takes into account the projected operating expenses and maintenance costs of the Club and Club Resorts and includes provisions for Reserves. This is necessary to allow for the provision of:

- a) Quality service standards designed to meet Member expectations;
- b) Maintenance of Club Resorts to meet Member expectations;
- c) Sufficient Reserves to allow for periodical refurbishment and replacement costs.
